END-USER LICENSE AGREEMENT FOR TUSCAWILLA CREATIVE SERVICES, LLC-READ CAREFULLY: This Tuscawilla Creative Services content End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and Tuscawilla Creative Services, LLC ("Tuscawilla Creative Services" or "Faith Works Images") for the Faith Works Images.

By licensing, copying or otherwise using any portion of the Faith Works Images, you agree to be bound by the terms of this EULA. If you do not agree to the terms of this EULA, do not use the Faith Works Images. Please read this Agreement carefully. Your use of the Faith Works Images is subject to the terms of this Agreement. Copyright laws and international copyright treaties, as well as other intellectual property laws and treaties protect the Faith Works Images.

The Faith Works Images are licensed, not sold.

- 1. GRANT OF LICENSE. Tuscawilla Creative Services, LLC, as Licensor, grants to you, the Licensee, a limited, nonexclusive right to use the Faith Works Images in your own original multimedia productions and for posting on your website or on social media websites (such as but not limited to Facebook and Twitter) without restriction. As part of your use, you may change the images by adding text, logos, URLs, etc. Neither the Faith Works Images nor any portion thereof may be resold or redistributed as individual images, image collections, or any other form of stand-alone image collection except as integrated into your own multimedia works or posted to social media websites. All rights not expressly granted to Licensee are reserved to Tuscawilla Creative Services, LLC or its licensors.
- 2. FAITH WORKS IMAGES OWNERSHIP. Tuscawilla Creative Services, LLC shall retain full and complete title to the Faith Works Images and all subsequent copies of the images, regardless of the media or form on or in which the original copies may exist. The License is not a sale of the original images or any of the underlying material.
- 3. COPYRIGHT. All rights, title, and interest in and to the Faith Works Images and any copies of the Faith Works Images are owned by Tuscawilla Creative Services, LLC. Copyright laws and international treaty provisions protect the images. Therefore, you must treat the Faith Works Images like any other copyrighted material, except that you may make copies only as provided in this EULA.

- 4. RESTRICTIONS ON USE. - 8. LIMITATIONS ON LIABILITY. In no event will Tuscawilla Creative Services, LLC, Tuscawilla Creative Services, LLC's affiliates or the third party providers' liability to you or any third party exceed the price paid by you for the Faith Works Images.
- 9. EXCLUSION OF REMEDIES. This EULA shall be governed by the laws of the United States and the State of Florida, irrespective of Florida's conflicts of laws rules. Any action arising out of or relating to this EULA may be brought exclusively in the appropriate state or federal court in Seminole County, Florida, and Tuscawilla Creative Services, LLC and you irrevocably consent to the jurisdiction of such courts and venue in Seminole County, Florida. This EULA constitutes the entire agreement between Tuscawilla Creative Services, LLC and you with respect to the subject matter of this EULA. Sections 7 through 9, and 13 will survive the termination of this EULA.
